

## **Lidl Plus Super Spin Boucher Road - Terms & Conditions – NI** **Conditions of Participation in Super Spin**

### **1. Overview**

Lidl Northern Ireland Limited (the 'Promoter') having its place of business at Dundrod Road, Nutts Corner, Antrim BT29 4SR, Northern Ireland. (hereinafter referred to as 'Promoter') is conducting a promotion called Lidl's spin of surprises scheme ('Super Spin') to reward qualifying customers with digital reward coupons ('Super Spin Coupons').

Lidl Plus contains a promotional feature called Super Spin, which is only accessible to registered Lidl Plus members. In order to use Super Spin, you must:

- Be a registered Lidl Plus user. You can download the Lidl Plus app from the "App Store" or "Google Play Store".
- Set your Lidl Plus country to Northern Ireland.
- Be of a minimum of 18 years of age.
- Complete a qualifying transaction at the Lidl Boucher Road store located at 2 Windsor Way, Boucher Road, Belfast.
- Some products are excluded from qualifying for the minimum spend for Super Spin such as lottery, newspapers, medicines, gift cards, infant milk formula, mobile top-up, checkout bags, and alcohol products.

### **2. Participation**

By using Super Spin, you agree to Lidl's terms and conditions for Super Spin.

Super Spin will commence at the opening the Lidl Boucher Road store located at 2 Windsor Way, Boucher Road, Belfast in Northern Ireland on 12.09.2024 and end at the closing of the Lidl Boucher Road store located at 2 Windsor Way, Boucher Road, Belfast in Northern Ireland on 15.09.2024 ('Promotional Period').

Super Spin will replace the regular Scratch & Win campaign for these dates only at the Lidl Boucher Road store located at 2 Windsor Way, Boucher Road, Belfast in Northern Ireland.

To participate, you must identify yourself as a Lidl Plus customer at the checkout during the payment process by scanning your Lidl Plus card.

- In order to qualify for a Super Spin Card, you must make a minimum purchase of £10.00 ('Minimum Spend'). Excluded products listed at point 1 above will not count towards the Minimum Spend.
- After each Minimum Spend, you will automatically receive a digital Lidl's Spin of Surprises on your device via the Lidl Plus App.
- You must click the digital Lidl's Spin of Surprises, so that the wheel appears and then tap the green button in the middle to spin the wheel. You will be deemed to have entered Super Spin when you tap the green button in the middle of the wheel within 7 days after you have made a purchase (Spin period).
- Please note that you will only receive one Super Spin Coupon per day i.e. if you complete two transactions within 10 hours you will only receive one Super Spin Coupon.
- Super Spin Coupons have a specific validity period which is displayed on the coupon and if unused after this date, they will disappear from your Lidl Plus app.
- When a Super Spin Coupon has expired or is redeemed, it automatically disappears from the view and will not be redeemable.

### 3. Super Spin Coupons

Only Lidl Plus app users who meet the entry criteria and qualify through the Minimum Spend are eligible for a Super Spin Coupon (Qualifying Participants). Qualifying Participants can enjoy Super Spin with the fun of knowing you will win a gift every single time! There is no element of lottery or luck, we believe in rewarding everyone, every time!

Super Spin Coupons range from £10 off coupons, free products and percentage discounts.

The mechanics of Super Spin have been set up so that the average of 1 in 10 transactions will receive a £10 off Super Spin coupon.

Super Spin Coupons are displayed to the user as a coupon in the "Lidl Treats" section of the Lidl Plus app and are subject to the following redemption criteria:

- Super Spin coupons relating to free products and percentage discounts are redeemable only in Lidl stores in Northern Ireland.
- Super Spin Coupons must be presented at the time of redemption, at the till. No minimum spend is required where the Super Spin Coupon relates to a free item. Super Spin Coupons cannot be redeemed on the purchase which triggers the Super Spin.
- The Super Spin Coupon must be activated and redeemed during the specified validity period stated on the Super Spin Coupon. See individual Super Spin Coupons for terms and conditions.
- The £10 off Super Spin Coupon specifically can only be redeemed in the Lidl Boucher Road store located at 2 Windsor Way, Boucher Road, Belfast in Northern Ireland.
- The £10 off Super Spin Coupon is non-transferable, non-exchangeable and no cash alternative will be offered.
- £10 off Super Spin coupons must be used in a single transaction and cannot be redeemed against standard exclusions. Exclusions include alcohol, lottery tickets, newspapers, magazines, medicines, gift cards, selected nutritional supplements, infant formula, mobile top-up and checkout bags.
- If the Super Spin Coupon value is higher than the purchase amount, the difference is forfeited by the user and is non-refundable. The balance will not be given in cash.
- Super Spin Coupons cannot be redeemed against purchases already made.
- Screenshots, pictures or online printouts of coupons will not be accepted.

### 4. Notification

If a Lidl's Spin of Surprises is issued to you, it will appear on the home screen.

The Super Spin Coupon is revealed immediately after you've spun the wheel. Super Spin Coupon details will be in the "Lidl Treats" section of the app after the user clicks "Save" once the Super Spin Coupon is issued.

Lidl may from time to time use push notifications that you can enable to receive a notification on your device that you have a Super Spin Coupon available to use via the Lidl Plus app. Enabling push notifications is **not** a requirement to enter.

### 5. Liability

Each participant in the feature understands and accepts that Lidl is not liable for, and cannot be held liable for, errors, losses and irregularities that may arise when the information is sent, if these are caused by disruption or by any other error or omission arising from problems in telecommunications, data traffic, congestion or internet connection, or for any other reason that is not attributable to Lidl. Lidl shall not be responsible for any loss, injury, damage or disappointment suffered to participants as a result of their participation in Super Spin and liability is excluded to the maximum extent permissible by law.

## **6. Exclusion**

Participation in Super Spin by groups of individuals, automatic services or professional services is not permitted.

Lidl reserves the right to deem any participant ineligible to redeem a coupon awarded in Super Spin if in its sole view it believes that these terms and conditions or the spirit of the giveaway have been contravened.

## **7. Early termination**

Lidl reserves the right to amend, cancel or suspend the Super Spin feature and its gifts without notice at any time.

## **8. Taxes**

Lidl is not responsible for any tax or other liability which may arise to participants in relation to their participation in Super Spin.

## **9. General**

Lidl reserves the right to replace the Super Spin Coupon with an alternative of equal or higher value if circumstances beyond Lidl's control make it necessary to do so. Lidl reserves the right to refuse entry to Super Spin or to award a Super Spin coupon to anyone in breach of these terms and conditions of participation or where it deems it necessary to do so. The decision of Lidl regarding any aspect of Super Spin is final and no correspondence will be entered into about it. Super Spin is governed by Northern Irish law and the courts of Northern Ireland shall have exclusive jurisdiction over interpretation of same.
