## NI Favorina Coupon Plus – Terms and Conditions

## 1. Participation in Favorina Coupon Plus

To participate in Favorina Coupon Plus, each participant will need to:

**Step 1.** Install the Lidl Plus App on their smartphone or device and create a Lidl Plus account (this step shall not be required for participants who are already Lidl Plus users); and

**Step 2.** Make a minimum transaction spend of £10.00 on Favorina products during the promotion to qualify for a reward coupon ('**Minimum Transaction Spend**').

Participants can view their spend amounts in relation to the Minimum Transaction Spend during the Promotion Period on the homepage of the Lidl Plus App.

# 2. Reward

- **2.1** Participants who achieve the Minimum Transaction Spend will receive a guaranteed reward coupon to be redeemed against a future transaction. Participants will receive an additional reward at spend targets of £15 & £25 respectively.
- **2.2** Favorina Coupon Plus Reward Coupons are delivered to the 'Treats' section of the Lidl Plus app promptly after completing a Minimum Transaction Spend qualifying transaction. Participants have 7 days to use Reward Coupons from the date of issue.
- **2.3** Favorina Coupon Plus Reward Coupons can only be redeemed against future transactions and not against the transaction qualifying for the Minimum Transaction Spend.
